RESTRICTED BYWAY ON GREEN LANE, SKERTON, LANCASTER  
DEFINITIVE MAP MODIFICATION ORDER 2025**

This Order is made by Lancashire County Council ("the authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act namely the discovery by the surveying authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, namely a restricted byway.

The authority have consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby order that:

1. For the purposes of this Order, the "relevant date" is 22 January 2025.
2. The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council Restricted Byway on Green Lane, Skerton, Lancaster Definitive Map Modification Order 2025.

## SCHEDULE

### PART I

#### MODIFICATION OF THE DEFINITIVE MAP

##### DESCRIPTION OF PATH OR WAY TO BE ADDED

Restricted byway known as Green Lane from an open 'T' junction with Green Lane U18462 immediately north of Beaumont Hall Canal Bridge (point A on the Order Map) running in an east north easterly direction along a track on the north side of the Lancaster Canal past a junction with Footpath FP0131007 (point B) and continuing to the junction with FP0115019 (point C) from where it continues, turning north along the continuation of Green Lane U18785.

The route is shown on the Order Map between points A-B-C as a broken green line.

The total length of the route is 0.34 km and the width varies between 3.5m and 7m

### PART II

#### MODIFICATION OF DEFINITIVE STATEMENT

##### VARIATION OF PARTICULARS OF PATH OR WAY

The Statement to be added for Lancaster 65 to read as follows:

##### **Lancaster:**

"No. of path: 65

Kind of path: Restricted byway

Position: Restricted byway known as Green Lane from an open 'T' junction with Green Lane U18462 immediately north of Beaumont Hall Canal Bridge (grid reference SD 4792 6383) running in an east north easterly direction along a track on the north side of the Lancaster Canal to junction with Footpath FP0131007 (SD 4803 6390) and continuing to the junction with FP0115019 (SD 4821 6401) from where the track turns north and continues as Green Lane U18785.

Length: 0.34km

Other particulars: "Width varies between 3.5 and 7 metres as shown on the Ordnance Survey 25 inch Sheet XXX.7 surveyed 1890 and published 1892.

Limitations: None. "

No. of Path: "7"

Kind of Path: "Footpath"

Position: "Lancaster Restricted Byway 65 at SD 4803 6390 to A6 Road."

Length: "1 mile"

**The Statement for Halton-with-Aughton 19 to be amended to read as follows:**

No. of Path: "19"

Kind of Path: "Footpath"

Position: "From East side of Halton Road Bridge (on Class III No. 201) to junction with Green Lane U18462 and Lancaster Restricted Byway 65 at SD 4803 6390 to A6 Road."

Length: "0.08 miles"
